PAYMENT OPTIONS:

Payment options will be available with a discount offered to members who pay the full membership up front. Full payments can be made by cash, check, or an electronic funds transfer. Full payments may also be paid by Credit Card, but a 4% convenience fee will be added to the total amount charged. For those choosing the installment option, dues will be billed equally over six (6) months from April through September. Monthly installments will be charged to your credit card on file on the 10th of each month with no convenience fee.

ASSUMPTION OF LIABILITY

Applicant understands and agrees that Applicant is assuming no liabilities whatsoever in connection with this membership other than the payment of the sum set out above, any applicable membership dues and charges incurred by Applicant, Applicant's family and Applicant's guests in the use of the Club and that such membership does not confer upon Applicant any ownership, interest, or rights of any nature in the Club property or assets, as further provided in the Membership Plan. Applicant understands that any use of the facilities at the Club by Applicant, Applicant's family or Applicant's guests is done at their own risk, and the Club, the Owner and their owners, employees and agents are not liable for personal injury, theft, or loss of personal property, as further provided in the Membership Plan.

PAYMENT OF MEMBERSHIP ACCOUNT

Payment of account is due on the 10th of the monthly statement; The applicant agrees to keep a valid credit card on file that will automatically be charged all dues and related charges to account on the 10th of every month. The account holder may pay by check, cash, or money order before the 10th of every month if they so choose to (Please note there will be a \$35.00 charge for any returned checks from the bank). The applicant agrees that the club may assess a late charge of \$25.00 for any transactions unable to be processed using the credit card on file. The account holder's membership will be placed on suspension with no further access to the club until said account is made current. Payments on delinquent accounts apply first to reduce late charges and accrued dues, next to food and beverage charges, then to any other charges. The account holder, by signing this agreement is allowing Union Country Club to charge all monthly related account activities to the provided credit card on file on the 10th of every month. Applicant agrees to pay all reasonable attorneys' fees, investigator fees, and costs in the event this account is turned over for collection. The membership card (if applicable) shall remain the property of Union Country Club at all times and must be returned to the club upon demand.

RESIGNATION/TRANSFERABILITY/REFUNDS

Applicant may resign from the Club by giving written notice to the Club. The effective date of the resignation will be thirty (30) days after the date the Club receives Applicant's written notice. All charges for which Applicant is liable are due upon the effective date of resignation. Transfers may be made solely through the Club, subject to the terms, conditions and restrictions set forth in the Membership Plan. **NOTE: DUES ARE NOT PRORATED OVER 12 MONTHS.**

It is understood and agreed that there shall be only one (1) Member per membership (the "Primary Member"); membership shall not be issued in joint names. With regard to any or dispute about the ownership of a membership, the Club shall rely on this agreement to confirm ownership of the membership in the name of Applicant, who shall be the Primary Member. Notwithstanding the foregoing, in the event of a personal divorce, this membership is not divisible and shall be allocated by agreement of all claimants, or in the absence of an agreement, by court order. Such allocations are subject to the sole approval of the Club. The successor to the membership shall execute all necessary papers and pay all transfer fees required by the club. Dues received are not refundable.
